# 1) About Special Olympics Singapore (SOSG)

#### Mission

To promote and provide year-round sports training and athletic competition in a variety of Olympic-type sports for children and adults with intellectual disabilities, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy and participate in a sharing of gifts, skills and friendship with their families, other Special Olympic athletes and the community.

#### Vision

Enhancing the potential of athletes with intellectual disability and celebrating the human spirit common to all.

## 2) Invitation to Quote (ITQ)

In this Invitation to Quote, Special Olympics Singapore are inviting bowling coach service providers or bowling coaches to submit a formal proposal for the provision of comprehensive bowling coaching arrangements, and related services to SOSG in accordance with all the terms and conditions as set out in the ITQ.

# 3) Submission of Quote

Each Quote must be submitted in accordance with this ITQ. Any Quote not made in accordance will not be considered. Bidders will be bound by the submitted proposal and deemed to have submitted a declaration of compliance with this ITQ.

Submission of proposals must be sent by 2359 (GMT+8) on 7 March 2025.

In the event that SOSG seeks clarification upon any aspect of your quotation, you are required to respond within the next **two (2)** working days.

Vendors are required to quote for a minimum of one of the days to be evaluated. Vendors are allowed to quote from one session to all the sessions listed.

#### **Special Olympics Singapore**



Submission of quotation document are required to state the following:

- a) A brief summary of experience
- b) The sessions that the vendor is interested to take up
- c) Hourly rates of coaches

All coaches must possess a valid First-aid certificate.

#### 4) Evaluation Criteria

All submitted proposals will be evaluated based on the following merits:

- a) Meeting the tender specifications.
- b) Completeness & reliability of services.
- c) Cost effectiveness.
- d) Track record and related experience.

Appointed vendor will be notified via email within **Seven (7)** working days after submission deadline.

# 5) Specifications

Comprehensive Bowling Coach Arrangements from 1 April 2025 to 31 March 2026.

- a) Curriculum and Training Plan to firm up a 1-year Training Plan for the athletes;
- b) Coaching and Guidance to provide coaching to athletes with intellectual disability according to the training plan;
- c) Monitoring to monitor the progression and well-being of the athletes;
- d) Working with on-site Volunteers to work together with the on-site volunteers to ensure meaningful engagement of the athletes.
